

Figure 1—Geographic Boundaries for the Mexican Wolf under the 1998 Final Section 10(j) Rule.




15. Have wolves affected your hunting/guiding? If so, please explain in detail the effect.

- 19. The revised rules set a population goal of Mexican wolves at 300-325. If the number of wolves triples, how will that affect your hunting/guiding?
- 20. Do you think that currently there are sufficient wild ungulate numbers (e.g. elk, deer) in the areas that you hunt/guide to provide for the demand by hunters? Please provide as much detail as possible in your explanation.

21.	Has your state wildlife management agency reduced or changed any quotas, number of licenses issued, take methods allowed, etc. in response to impacts by Mexican wolves on game species?
22.	What will happen to your hunting/guiding operation if the revised federal regulation for Mexican wolves remains in effect?
23.	Hunters, guides and outfitters are conservationists. Please explain how the increases and expansions of Mexican wolves harm your interests in wildlife conservation.
24.	If you are a guide/outfitter, do you have any hunting clients who we could contact who have witnessed the impact of wolves on the prey populations in the areas that you guide?
